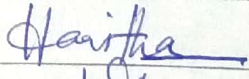
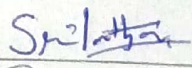
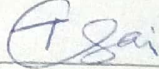

Decision:

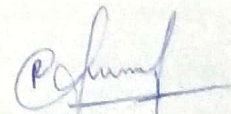
- Strengthen the teaching-learning process through regular tutorials, remedial classes, assignments, and continuous assessment.
